




2016 APQN Annual Repot

On May.15, 2016, the APQN Board Meeting was held in the Secretariat Room, InterContinental Fiji Resort & Spa, Natadola, Fiji.

Dr. Jagannath Patil, Prof. Angela Hou Yung-chi, Prof. Li Yaogang, Prof. Jianxin Zhang and Prof. Colin Peiris made the report. Dr. Galina Motova and Ms. Erika Soboleva were invited to prepare



for the proposal for 2017 conference. NCPA will prepare for the proposal at first. If there is issue, AACCUP will also make the preparation. The board made discussion and the approval of APQN Quality Award 2016 and the Issue of the Bid of Secretariat. Prof. Jianxin Zhang released the strategic Plan for 2016-2019.

APQN Additional Board meeting

On September 15, 2016, APQN Additional Board Meeting was held in Bangalore, India. It was held at the same venue of "Global Summit on Quality Higher Education: Sharing Values and Fostering Trust beyond Borders" organized by NAAC, India and co-organized by APQN.



The meeting summarized 4 achievements since the presidency of the 5th Board as following: 1) having releasing "Dissolving Boundaries

for a Quality Region: APQN Strategic Plan 2016-2019"; 2) having set up the first Self-fundraising Project; 3) having completed the application process of Wenhui Award organized by UNESCO; 4) Having Co-hosted the Global Summit on Quality Higher Education: Sharing Values and Fostering Trust Beyond Borders.

As for the future activities, 9 items have been proposed: 1) APQN 2017 Conference in Moscow; 2) the release of APQN Brochure and APQNews(twice every year); 3) the amendment of APQN Procedure; 4) to publish Proceedings of 2016; 5) to publish the Journal of HEED; 6) the cooperation with APQN members; 7) to promote APQR and Quality Label; 8) to seek for opportunity of applying for Erasmus-plus-programme; and 9) about Co-opted members.



ACTIVITIES & PROJECTS

APQN Annual Conference

APQN 2016 Conference was held in Natadola, Fiji on 26-27 May, 2016, which was just one day after the INQAAHE 2016 Forum in the same venue. Both the 2016 APQN Conference and INQAAHE Forum were hosted by Fiji Higher Education Commission (FHEC), Fiji. There were 144 participants from 30 countries, including



87 international participants, 21 Pacific participants, and 36 local participants. The main theme for the APQN 2016 Conference was "Sustainable Development of Quality Assurance in Higher Education". The sub-themes were: 1) Quality Assurance and Sustainable Development; 2) The Benefits of Sustaining EQA, IQA, Qualifications Framework and Peer Review System; 3) Higher Education Trends and Accountability of QA in Asia Pacific in Terms of Productivity, Equity and Cost; 4) Quality Assurance of University Governance and Management; 5) Assuring Standards and Quality of Higher Education: Teaching and Learning; 6) Managing Quality of Cross-Border Movements in Higher Education; and the Internet Generation and its Implication on Higher Education Quality Management (OER, MOOCs, Online Distance Courses and Assessment).

The new Board for 2016-2019 with Prof. Jianxin Zhang as President took over for the leadership of APQN in the AGM. Prof. Jianxin Zhang delivered an inaugural speech as the new elected President, and presented her dream for a sustainable and vibrant APQN. As there were lots of new challenges and opportunities in the new era, Prof. Zhang would like to commit more passion and energy, and she also encouraged members to work shoulder by shoulder just like brother and sister of one family for the development of APQN.

APQN Strategic Plan 2016-2019

The 5th board began its term after the formal announcement on May 27, 2016 in the Annual General Meeting (AGM) in Fiji. To realize the value of "committed to quality higher education, and supportive of quality organizations in the region" and to reach the vision of "to be a self-sustaining Network, a first point of reference for advice or support, efficient in its operations and open in its information sharing." The 6th Guided Online Forum

APQN launched the 6th online forum on March the 2nd which lasted for a month. In order to realize the new QA Trends in Asia, the topic of the forum is "Quality Assurance for Sustainable Learning, Teaching and Research in Higher Education", which was mainly focused on quality management of distance education, including online courses, programs, MOOCS, OER in terms of the role of QA organizations and institutions. They are both expected to respond effectively to the global trend by various stakeholders.

In addition, current trends on quality assurance research will be included on behalf of APQN members. Hence, there were 3 more sub-themes to be further discussed, namely, 1) Quality Management of Distance Education; 2) External Review of Online Courses, MOOCs and OER; and 3) Research on Quality Assurance of Higher Education.

Four facilitators were invited to lead the discussions: Prof. Dr. Angela Yung Chi Hou (Vice President of APQN), Prof. Stamenka Uvalic-Trumbic (Former Chief of the Higher Education Section of UNESCO), Prof. Deane Neubauer (Co-Director of the Asia Pacific Higher Education Research Partnership) and Prof. Asha Kanwar (President and Chief Executive Officer of the Commonwealth of Learning).



Global Summit on Quality Assurance of Higher Education

On September16-17, 2016, the National Assessment and Accreditation Council (NAAC), a premier National Quality Assurance Agency in India, in collaboration with APQN, held "Global



Summit on Quality Higher Education: Sharing values and fostering trust beyond borders" in Bengaluru in India.

It was for the first time the key quality networks and agencies from Asia, Europe, America and Africa joined hands to be the partners of event and assembled on same platform. Global partners included organizations such as CHEA (Council for Higher Education Accreditation) from USA. 120 delegates from India and abroad, over 20 foreign nationals representing global quality assurance bodies participated in the Global Summit focusing on Higher Education Quality Accreditation. This event is the culmination of the efforts by NAAC and APQN in bringing together global quality assurance agencies and heads of accredited institutions from across the country under one platform.

"Bengaluru Statement for 2016 on Next-Generation Quality Assurance of Higher Education: A Shared Vision and Commitment for Fostering Partnership Beyond Borders" was the culmination of the global summit and is counted as the major landmark in the International history of higher education quality assurance.



Book release: a Platform to Share QA Vision and Commitment

During the 2016 APQN Annual Conference (AAC), proceedings from 2012 and 2015 AAC were launched by Dr. JP (the 4th President) and Prof. D. Jianxin Zhang (the 5th President) at Natadola, Fiji.





The Academic Proceeding of 2012 APQN Conference "External Quality Assurance in the Asia-Pacific: What has Changed over a Decade?" was published by APQN, edited by Dr. Jagannath Patil. The proceedings consists of 19 selective conference papers submitted to 2012 AAC held on 29 February-2 March 2012 at Siem Reap Angkor in Kingdom of Cambodia.

The Academic Proceeding of 2015 APQN Conference "Globalization and Diversification of Quality Assurance of Higher Education" has been formally published by the Yunnan People's Publishing House. Prof. Jianxin Zhang (APQN Board member) and Dr. Jagannath Pail (APQN President) are the joint chief editors. It consists of 6 sub-themes and 49 selective papers submitted to 2015 AAC held on April 17-19 2015 in Kunming in China.

2016 HEED report

Jointly published by Higher Education Evaluation and Accreditation Council of Taiwan(HEEACT) and Asia-Pacific Quality Network, Higher Education Evaluation and Development (HEED) has successfully released its two issues in 2016. HEED discovers global aspects and compelling researches that allow readers to better understand and make critical judgments on higher education evaluation and development. It serves as a platform that welcomes authors, professors, and other erudite scholars from similar fields to share and contribute their findings to the advancement of higher education.

Ten original papers, studies and case analyses underwent a double-blind peer review. With five papers each, the first issue Vol. 10.1 responds to the public's concern over QA accountability and predicts the new trends of QA for the next decade, and explores how institutions and QA agencies can collect and use data for institutional self-improvement and QA policy making. The second issue Vol. 10.2 is a special issue on student learning and assessment in higher education. HEED has successfully drawn international attention. The number of paper downloads has increased up to 1300 times in 2015. Starting the year of 2016, HEED formed a new Editorial and International Advisory Board. By inviting several top higher education scholars in Asia and heads of international networks worldwide, HEED is building itself as a leading QA journal and bringing new insights into higher education.

International Conference on Teaching & Learning Quality

Assurance

This year Macao Polytechnic Institute (MPI) joined hand with the Asia-Pacific Quality Network (APQN) again to co-organize the conference with the theme on





'The New Frontiers of Teaching and Learning Quality Assurance in Higher Education' from 22 to 24 November 2016. International scholars and experts are welcomed to submit papers on different quality aspects of teaching and learning.

APQR Website Launched in Macao

The formal release of website took place in presence of APQR founder Chairperson Dr. Jagannath Patil, APQN President Prof. Dr. Jianxin Zhang and Macao Polytechnic Institute (MPI) Vice

President Prof. Marcus Im, on the occasion of International Conference jointly organized by MPI and APQN at Macao during 23-24 November, 2016.


APQR set up by APQN is a Register of external quality assurance agencies (QAAs) that demonstrates certain thresholds of maturity. An



independent external review by peers would be the backbone of the APQR. After initial mentoring by APQN for 2-3 years, it is expected that APQR would be an independent entity on lines of European Quality Assurance Register (EQAR).

Database of Consultants

As of the 1st October 2016, the Database is composed of 188 consultants from 56 countries/territories. They are willing to provide advice to the member agency in the world, especially in the Asia-Pacific Region. Different consultants have different social backgrounds so that they are competent to advice on different specific and matters of interest to agency.





Many quality assurance system of higher education have been crying out for good consultancy for excellent quality. Through APQN Database of Consultants, hopefully they will get what they need. In order to utilize the Database effectively beyond boundary, the Database should be used as a valuable tool and be well benefited. APQN encourages and welcomes members' valuable opinion and proposals.

Workshop of APQN and APQR's Memberships in Indonesia

On the 18-20th November, 2016 IAAHEH (Indonesian Accreditation Agency for Higher Education in Health) Annual Meeting was held in Century Park Hotel in Jakarta. Around 600 participants attended the seminar and the award ceremony.



On the same venue, APQN's workshop was held, where 11 participants from Indonesian nursing association and Indonesian Association of Nursing Education (AINEC) took part. APQN President introduced the 13-vear development of APQN, guided the team how to become an APQN member, third

gave instruction on how to be accepted onto APQR, and discussed how to launch nursing accreditation in Asia-Pacific. Dewi Irawaty and Elly Nurachmah from nursing team of IAAHEH presented and lead two groups to work on action plans. The workshop was a success to reach the goals to develop the strategic and operational plan on recognition program. It is for sure that both APQN and IAAHEH is not merely to award accreditation status for the study program, but more importantly, it is to build awareness, motivation, and concrete actions that will lead to the institutionalization of culture of continuous quality improvement.

THE REPORTS

President Report

On the sunny afternoon of the 27th 2016 in beautiful Natadola in Fiji, Dr. Jagannath Patil, APQN's 4th President announced that I was elected the 5th President. On behalf of the new Board, I spoke three points at the short inaugural address: 1) great thanks for the trust on the 5th Board; 2) the Board members feel honored, and at the same time also felt great "pressure"; 3) the Board members are full of confidence in the period of the next 3 years (2016-2019). At last, I said: "I have a dream: everyone in APQN, especially me myself, do not ask what APQN can do for us, but we should ask what we can do for APQN. "

One year passed by before we know it. With the great contribution and support of the immediate past President, APQN has made obvious achievements. I have the honor to present the president annual report for 2016 to APQN General Council, to 197 members in 2016.

I. All in a Year's Work

Looking back in the year of 2016, we are very proud. This year, APQN with 197 members entered its 13-year-old blooming age, showing its vibrant, vigorous tendency of sustainable development.

In this very year, APQN successfully completed the new election at expiration of the last office term. It ensured the ship of APQN to continue its voyage to the "blue sea" of education quality without border under the direction made by the previous 4 Boards as well as under the leadership of the new Board.

In this very year, APQN completed "Dissolving Boundaries for a Quality Region: APQN Strategic Plan (2016-2019)", in which APQN strengthen the goal, the mission, the vision and the value made by the previous 4 Boards. It ensured APQN's first step to complete the 7 goals and actions along with 10 targets in the next 3 years.

In this very year, APQN launched the first self-fundraising project of "APQN' Sustainable Development", reversed APQN Brochure and began to "the Compilation of APQN Procedure Manual" pursuant to APQN Constitution, which added more chapters such as "volunteer", "fund-raising project", "publication" and other chapters based on the original version. It ensured APQN's ability to function systematically and sustainably.

In this very year, APQN, together with National Assessment and Accreditation Council (NAAC) in India, released "Bengaluru Statement for 2016 on Next-Generation Quality Assurance of Higher Education: A shared vision and commitment for fostering



partnership beyond borders". It ensured that APQN would join hands with the colleagues from Asia, Europe, America and Africa to establish a global quality platform.

In this very year, APQN held 2016 APQN Annual Conference (AAC) and Annual General Meeting(AGM) hosted by Fiji Higher Education Commission in May in Fiji, co-organized Global Summit on Quality Higher Education in September in India, held the International Conference on Quality Assurance co-operated with Macao Institute College in November in China, held the Workshop of APQN's and APQR's Memberships with Indonesian Accreditation Agency for Higher Education in Health (IAAHEH) in Jakarta, published 2 proceedings of AAC papers ...


II. APQN's Sustainable Development

World Commission on Environment and Development, Our Common Future (1987) defies "Sustainable development is development that meets the needs of the present without compromising the ability of future generations to meet their own needs". "The Sustainable Development Goals (SDGs)", officially known as Transforming our world: the 2030 Agenda for Sustainable Development, is a set of 17 aspirational "Global Goals". It proposes Goal 4: Quality Education - Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all. In order to realize APQN's sustainable development and its mission of "enhancing the quality of higher education in the Asia-Pacific Region through strengthening the work of quality assurance agencies (QAAs) and extending the cooperation between them", in 2016, we made the APQN Strategic Plan as the guidance for the new general council in the next three years (2016-2019)

2016-2017 will be the year of procedure building, 2017-2018 is the year of staff capacity building and 2018-2019 is the year of action and achievements. The 5 principles of APQN's Sustainable Development are: 1) target-orientated principle; 2) project-orientated principle; 3) SMART principle (Specific, Meaningful, Agreed-upon, Results-oriented and Tractable); and 4) Principle of sustainable development. Our 5 key words are "procedure-base, capacity-building, self-reliance, information-sharing and sustainable development".

In "APQN Strategic Plan (2016-2019)", APQN will complete 7 goals and actions along with 10 targets in the next 3 years.

Among all the projects that APQN is working on, "APQN's Sustainable Development" led by me is worth mention. 5 crucial factors of APQN's sustainable development might governance be: 1) and management; 2) financing;





3)efficacy; 4) achievement; and 5)sustainability. This project has both academic value and practical value and can help APQN reach its vision, value and missions and it will help APQN to realize its sustainable development as a non-profit & non-governmental organization.

Vice-President Report

Driven by global competitions, lifting internationalization level of higher education of a nation has been often adopted by governments as one of the most important strategies for human resources development and global talent attraction. Over years, a notable evolution in higher education internationalization was the rise of regional identity and cultural awareness throughout regional collaborations, engagement and alliances. In order to enhance regional integration and collaborations in higher education, several international quality assurance organizations play a major role. As a leading quality assurance network in Asia, APQN provides a quality platform not only bridging quality assurance organizations and institutions closely in Asia but also linking Eastern quality assurance community with the Western world.

With the efforts of the new APQN board and the support of all APQN members, the year of 2016 was quite productive and fruitful. I was so delighted to engage several new initiatives, which were implemented successfully, including holding 6th on-line forum, preparing APQN manuals, reviewing Database of consultants, publishing HEED in a new international publisher, and completing the 2013-2014 APQN proceedings.

In order to realize the new QA Trends in Asia, APQN launched the 6th online forum on March 2, which last one month, The online forum focuses on "Quality Assurance for Sustainable Learning, Teaching and Research in Higher Education", with three subthemes, "Quality Management of Distance Education", "External Review of Online Courses, MOOCs and OER", "Research on Quality Assurance of Higher Education". Serving as a Forum Convener, I invited three well-known scholars to lead and facilitate the discussions each week. They included Mr. Stamenka Uvalic-Trumbic, Former Chief of the Higher Education Section of the United Nations Organization for Education, Science and Culture (UNESCO); Professor Deane Neubauer, Emeritus Professor of Political Science at the University of Hawaii, Manoa, and Professor Asha Kanwar, President & Chief Executive Officer Commonwealth of Learning. More than 130 messages were posted throughout the forum. Altogether 80 quality assurance experts, representing 22 APQN member institutions from 12 different countries took part in this important endeavor during the month of March.

The Asia Pacific Quality Network (APQN) cooperated with the International Network for Quality Assurance Agencies in Higher Education (INQAAHE) to develop the database of consultants since 2009. Up to present, 186 experts have been included to the Database of Consultants after review. In order to realize the functions and utilities of the Database, three consultants were interviewed first, then a survey was conducted. APQN is planning to hold a workshop for the future prospect of the database by collecting more APQN members' opinions. Besides, APQN will also promote and market the database throughout APQN website, newsletters, conference, etc.

Strengthening its research capacity is the other objective of APQN. In 2014, HEEACT



with APQN jointly published an English journal Higher Education Evaluation and Development (HEED), a scholarly refereed journal aimed at encouraging research in higher education evaluation and development and raising standard of evaluation researches and QA, thus sharing outcomes of evaluation and developments and trends worldwide. Up to present, HEED has published more than 85 academic articles, including several from APQN member organizations. Starting in 2017, HEED is transforming into an E-journal with its contents published by an internationally recognized publisher, Emerald, as open access on a dedicated research platform and disseminated globally.

Publishing conference proceedings is another APQN task. The 2013-2014 proceedings consist of three sections and 11 chapters discussing global new trends in quality assurance, quality assurance issues at the national contexts and the best practices of QA approaches in Asian higher education.

Thanks to the support of APQN members, I continued to serve as Vice President. I am so grateful that I was given this precious opportunity again to work with President Zhang and other board members in the projects above. With mission and passion, I will stand aside with the new APQN board and members, bringing APQN into the next brighter decade.

Secretary/Treasurer Report

Thanks to the leadership of the Board, especially the Office Bearers and the continuous support of the members and interested parties, the APQN Secretariat in 2016 has effectively and efficiently completed the routine work with more innovation, which are valuable for the vibrant and sustainable APQN. The details for the work of the Secretariat in 2016 are following.

1. APQN Members and the Board

The Secretariat has devoted lots of energy to attract new members, such as approaching the prospective members in the database of APQN and the non-member participants of APQN's activities, answering queries in the process of application and timely feedback after pre-review of the application, providing support for the review of Membership Review Committee, and making follow-up for the review of the Board. The number of APQN's members in all categories has reached to 197 from 40 countries or territories with 31 new members. For the existing members, the Secretariat has updated their information and provided detailed and thoughtful consultations.

The Secretariat has communicated frequently with the Board, especially the President and Vice President for the important issues, as they are the APQN Office Bearers along with the Secretary/Treasurer.



2. APQN Annual Conference and AGM

APQN 2016 Conference was held in Natadola, Fiji on 26-27 May, 2016, which was just one day after the INQAAHE 2016 Forum in the same venue. Both the 2016 APQN Conference and INQAAHE Forum were hosted by Fiji Higher Education Commission (FHEC), Fiji. There were 144 participants from 30 countries, including 87 international participants, 21 Pacific participants, and 36 local participants.

The Fiji Higher Education Commission (FHEC) hosted the APQN 2016 Conference and AGM, which just followed the 2016 Forum of the International Quality Assurance Agencies Network in Higher Education (INQAAHE) in the same venue.

The Secretariat has communicated with FHEC frequently for the preparation of the Conference and AGM, such as confirmation of the venue and hotels, release of the Call for Contributions and open of the online registration system. The Secretariat has also forwarded the Call for EoIs for the 2017 Conference and AGM for several times.

3. Management of Projects

The Secretariat has concentrated fully on the management and supervision of the APQN projects, including:

1) 2016 APQN Quality Awards,

- 2) Strategic Plan 2016-2019
- 3) Releasing of pins for HEECT electronic periodical
- 4) APQN Quality Label,
- 5) APQN 6th Online Forum,

6) Expansion of the Database of Consultants in cooperation with International Quality Assurance Agencies in Higher Education (INQAAHE),

7) Development of virtual library for its members for serving this purpose,

8) Publishing of 2015 Conference Proceedings

9) Exploration and Practice of the Asia-Pacific Quality Register (APQR),

10) Publications based on APQN 2016 Conference Papers.

The Secretariat has planned the activities, drafted and released the Call for EoIs, preliminarily reviewed the applications, made recommendation for the Board, conducted coordination and supervision, and provided technical support in the process and so on. In addition, the Secretariat also released the Call for Members and Experts to Join APQN Projects, to invite interested members to join in the existing/proposed projects of common interest and to conduct short term projects relevant to APQN's objectives.

5. Publication and Liaison

The Secretariat has actively taken the responsibility to collect and disseminate information among the APQN members and those interested to APQN. In the year of 2016, the Secretariat drafted, designed the APQN 2015 Annual Report, and distributed the hard copy to all members and uploaded the soft copy on the APQN website;



In the year of 2016, the Secretariat has continued the liaison and communication with the Bangkok Office of the United Nations Educational, Scientific and Cultural Organization (UNESCO), International Network for Quality Assurance Agencies in Higher Education (INQAAHE), European Association for Quality Assurance in Higher Education (ENQA), European Consortium for Accreditation in Higher Education (ECA), and Arab Network for Quality Assurance in Higher Education (ANQAHE). APQN has cooperated with INQAAHE for the expansion of Database of Consultants and with ENQA for the quality assurance of cross-border higher education. APQN also has signed MoU with the European Alliance for Subject-Specific and Professional Accreditation reinforce and provide a platform for the desired cooperation between the two networks.

6. Finance

In March, 2016, the Secretariat organized the annual audit for the 2016 Finance Statement, the audit report has showed that "the financial statements give a true and fair view of the financial position of Asia-Pacific Quality Network as at December 31, 2016, and of its financial performance for the year then ended in accordance with the Accounting Standards for Non-profit Organization."

According to the APQN 2016 Annual Finance Report, the operation cost of the Secretariat has kept about 60% of the annual income of membership fees. The Secretariat has made great efforts for the collection of the membership fees. Up to the writing of this report, about 70% of members have paid their 2016 membership fees.

7. Words for the Future

The year 2016 is also the year for the bid of the APQN Secretariat with the term from 2016-2019. On May 31, 2016 the Secretariat in Shanghai won the bid again and will continue its full support for the operation of the networks, and keep the efficiency and effectiveness. Within this period, except the assigned tasks of information distribution, administrative support and finance management, the Secretariat would like to creatively complete:

1) to make more promotional activities to attract more new members;

2) to broaden the sources of income by professional service to the international organizations, country governments, member organizations and other interested parties;

3) to strengthen the capacity-building the Secretariat staff.

Reports from the Board Members

It gives me great pleasure to summit a brief report on activities undertaken by me as an Asia Pacific Quality Network (APQN) Board member in capacity of Immediate Past President.

1. Asia-Pacific Quality Register (APQR) development:

The newly elected APQN Board 2016-2019 honored me with opportunity to continue as the Chairperson of the APQR of which I had privilege of being a founder during my tenure APQN President during 2013-2016. It is pleasure to inform all stakeholders that we have launched a brand new independent website of APQR named www.apqr.co. All the work of developing documents and guidelines for APQR is completed. Thanks to support of APQN President Prof. Dr. Jianxin Zhang and other APQR members, a good number of applications and queries have been received to join APQR.

2. NAAC-APQN Global Summit-2016:

I had privilege of making pioneering efforts as convener of "Global Summit on Quality Higher Education: Sharing Values and Fostering Trust Beyond Borders" jointly organized by APQN and National Assessment and Accreditation Council (NAAC) on 16-17 September 2016 at Bengaluru, which resulted into historic Bengaluru Statement 2016 on Next-Generation Quality Assurance of Higher Education: A shared vision and commitment for fostering partnership beyond borders.

Bengaluru Statement – 2016 called upon quality assurance networks, organizations and stakeholders of higher education to join hands and commit to work together to enhance quality in higher education in service of students and society.

NAAC, APQN and other partners have agreed to deliberate further on this statement and develop action plan by making specific commitments to deliver on the various issues raised for the benefit of quality in higher education. NAAC has already initiated a project on "Compilation of Good practices in Quality Assurance across the Globe", as follow-up of the summit.

NAAC and APQN together can take this agenda forward to promote QA capacity building in Asia-Pacific.

3. APQN Website:

The APQN Board has also entrusted me to facilitate launch of revamped APQN



website. The awards of contract have already been given and together with inputs of all board members, we hope to launch new APQN website during Annual Conference at Moscow, Russia.

4. Other highlights:

Apart from these issues it has been a great pleasure and privilege to be part of various APQN Board activities such as APQN Finance Committee, Program Committee, APQN Quality Information Portal, APQN Quality Label and various other initiatives under the committed and dedicated leadership of APQN new President Prof. Dr. Jianxin Zhang and enthusiastic Board members.

We hope to continue the legacy of APQN as the torch bearer of higher education quality assurance networking in Asia-Pacific.

After the 2016 AAC and AGM in Fiji, I have the following contributions to support APQN:

1. Approached and invited state universities and quality assurance agencies to apply for membership in APQN. I choose only those institutions with reputable name and integrity. Before the Moscow Conference, I will be able to submit one or two applications.

2. Expand APQN influence to Philippines. I invited APQN President Jianxin Zhang as guest speaker in our 30th AACCUP Annual National Conference. President Jianxin made us in APQN Board proud as she was able to explain to 472 heads of state universities and top educators what APQN is, its programs and projects, and its image as the second biggest QA body in the world. Dr. Jianxin has also been an excellent Ambassador of QA. She made many friends.

3. Proposal of Board Meeting. I proposed that the Board would have a meeting in Manila last February to be hosted by AACCUP, but it did not materialize. Reason: Board Members are too busy. I will propose again that next year; the Board makes an out-of-town meeting before the 2018 APQN and AGM, and AACCUP will offer to host the meeting in Manila.

4. I have convinced the AACCUP Board of Trustees to undertake the following projects:

1) Apply to host 2018 AAC and AGM. I have convinced our highest higher



education body, the Commission on Higher Education and the 110-member Philippine Association of State Universities and Colleges (PASUC) to support the AACCUP in this project.

2) Subject AACCUP to evaluation by a foreign body, possibly by APQR.

3) Organize an International Conference on the Internal Quality Assurance of Quality Assurance Agencies and Institutions to be held in December, 2017 or January, 2018. We will seek as partners in this project the Philippines Commission on Higher Education and the PASUC. We need the APQN as co-organizer or as endorser of the Conference.

5. I have regularly participated in APQN Board discussions on line.

My first year on the Board of APQN has been a real challenge and at the same time valuable experience. The main task of this year is hosting the APQN annual conference and GA in Moscow and tackles all the issues connected with the venue, visa and information support, accommodation and catering of the participants. The topics for discussion include both traditional issues of internal and external quality assurance and new trends: new methods of assessing student learning outcomes; interrelationship of accreditation and ranking systems. These topics are of interest not only for accreditation agencies but also for representatives of academic community. The title of the conference also reflects a distinguishing feature of the venue – it's the first time that the conference has been held in Moscow, Russia – the most western part of the Asia- Pacific Region, which presents a good opportunity for our European colleagues to participate in discussions.

All these arguments have served as a basis for a broad advertising campaign, which was launched in October 2016. The conference web site and advertising leaflets have been prepared; the journal Accreditation in Education has placed an article and an advertising block, information letters have been sent to Asian and European accreditation agencies. Advertising leaflets were disseminated among the delegates of INQAAHE conference in Bahrain and IREG in Qatar. I hope this effort would bear its fruit and the conference will gather together a wide range of participants.

Another important area of work is dissemination of information about the APQN activities in the Russian academic community. Russia has been traditionally oriented towards cooperation with the European region and is not quite familiar with the work of Asia-Pacific accreditation agencies. The information about the activities of APQN was presented at international and national conferences in Barnaul (September, 2016), Kaliningrad (November, 2016), Moscow (February, 2017). Even more important is to inform the Ministry of Education and other power bodies about the developments in the APQN network. With active and efficient involvement of APQN's President Jianxin official letters were sent to the Russian Ministry of Education and federal bodies of power informing them about AAC and APQN.



Besides, I have been actively engaged together with the Secretariat and the Board in collecting information about the participants for publishing a booklet; collecting and reviewing conference papers for choosing speakers and presenters for parallel sections. I am trying to be an active participant in all current APQN issues and discussions.

The ASEAN Quality Assurance Network (AQAN), a sub-regional network in South-East



Asia, consists of ten full members of QA agencies and national authorities responsible for external QA. It was established in 2008 and is a registered Entity with ASEAN. **Most of the members are also members of APQN.**

It has been established to support the roadmap for establishing higher education common space similar to the initiatives in Europe through the QA field. It is one of the many initiatives to support the ASEAN as a single community agenda, under the ASEAN Social and Cultural Community pillar. The road map identified the need to promote QA principles and practices, seeking common agreed core requirements, capacity building and this consequently led the development to the regional QA framework. Harmonization of the higher education is important in the ASEAN agenda for a single community where the human development through education and training is a predominant factor particularly for ASEAN Economic Community. There is shared consciousness of the benefits of collaboration and sharing, and the crucial role of QA in promoting harmonization in higher education. The role of QA is stated Kuala Lumpur Declaration and implementation work plans of 2016.

AQAN developed the regional QA framework in 2015. The ASEAN Quality Assurance Framework (AQAF) is an indigenous, development-oriented and a neutral instrument which serves as a common reference point to align QA systems, higher education institutions and qualifications across the region. Its purpose is to enhance the quality of education in the region and support the mobility of students, workers and services both within and outside the region and regional QA frameworks—European Standards and Guidelines (2015), Chiba Principles of APQN and INQAAHE GGP. The framework consists of 4 interconnected 'quadrants': EQA establishment, EQAA QA systems, internal QA of institutions as well as national qualifications framework. A robust QA system is intended to build zone of trust for the purpose of recognition of qualifications within ASEAN and beyond. Another driving factor is the establishment of the ASEAN Qualifications Reference Framework which requires a robust national QA system to be in place. This crucial factor has been instrumental in the recent development of new QA agencies in the region.

With the support of the EU SHARE project (2015-2019) and European QA experts, guidelines for agency reviews and institutional assessment were jointly developed. The project will assess the strength and appropriateness of the Framework on 4 mature agencies and guide capacity building for the younger agencies (2017-2018). Eleven higher education institutions will be assessed vis-à-vis the Internal QA Principles of AQAF. This exercise will also benefit the agencies and institutions involved.

The journey toward harmonization and regionalization is a long and challenging journey but it has begun with small steps and key instruments. The national systems will set their own roadmap to address this development and are encouraged to be guided by AQAF.
