INOAB DUTIES:


The Board shall have the following duties:

Foreword from the CEO

Greetings and Happy New Year to you all.

This is the first of a series of monthly newsletters TNQAB produces to inform the public of its activities and responsibilities.



At the end of June 2011 the grace period for free initial registration came to an end. It is unfortunate that some providers failed to achieve registration and they now have to pay the prescribed fees. This should not be seen as a penalty, but rather a reminder for us all to make use of the opportunity while it lasts. However, I urge those providers not to be discouraged but to make every effort to gain registration not only for their own benefits but more importantly for the future of their students and clients.

TNQAB steps into 2012 with renewed confidence and determination. Significant progress were made in its work towards international recognition through partnership arrangements with the New Zealand Qualifications Authority (NZQA) and the Pacific Register for Quality and Standards (PRQS) at the Secretariat for Pacific Board for Educational Assessment (SPBEA). TNQAB gained full membership in the International Network for Quality Assurance Agencies in Higher Education (INQAAHE), and is currently working towards attaining full membership at the Asia Pacific Quality Network (APQN). It is anticipated that in the near future TNQAB will be widely recognised internationally and the qualifications registered on the Tonga Qualifications Framework will gain automatic recognition internationally.

The new year also sees an increase in the staff of the Secretariat which will have a substantial impact on the Secretariat's performance and service delivery. Seven new staff have been recruited. The increase in staff serves two purposes: to build the capacity of the Secretariat and to fulfil organisational requirements from international partners.

Lastly, I wish to encourage training providers to keep working towards their registration and to make every effort to accredit and register their programmes and qualifications. This will take us a step nearer to Tonga's ultimate goal of achieving and maintaining quality education.

Accreditation

Registration:

New provider: Lavengamalle Technical Institute (LTI) is the newest provider to apply for registration. The application is now being processed and we look forward to work together with the management and the staff of this provider to complete the requirements. for registration.

Consultation Sched-

A schedule of consultation session has been developed to avail TNQAB Officers to meet with providers who are not yet registered. The purpose of these sessions is to identify areas where providers lack the necessary documentations and to guide providers in what needs to be done in order to meet the criteria for registration.

Consultation cont:

A similar schedule has been developed to provide assistance and guidance to providers on how to prepare their programmes of study for accreditation. It is hoped that these opportunities will improve and speed up the preparation for programme accreditation. Overseas Internship:

Pauline Moa underwent an internship at the Malaysian Qualifications Agency, Ma-Laysia from 10th October -21st October 2011. The purpose of the internship was to undergo on-the-job training on quality assurance procedures and processes, support services and site visits to higher institutions. This opportunity was a priority need for INOAB as it would certainly increase the capacity of the organization to conduct quality assurance of providers through registration and accreditation. The internship was funded by the International Network for Quality Assurance Agencies in Higher Education [INQAAHE].

Cooperation Arrangement with NZQA

NZQA Officers visit:

- INQAB and NZQA have entered into a cooperation arrangement in the field of qualifications frameworks and quality assurance in tertiary/post compulsory education to implement a 5-year programme for the benefit of both organizations, The Cooperation Arrangement focuses on two areas:
- i. organizational development for qualifications framework and quality assurance systems
- ii. staff capability
