## **APQN Constitution (Version 9.0)**

# Amended by the sixth Board onSeptember15, 2019; Approved by the General Council on November 30, 2019

#### I. Name

- 1. An organization is established under the name of the Asia-Pacific Quality Network Inc. (APQN).
- 2. APQN intends to operate as a regional network in association with the International Network for Quality Assurance Agencies in Higher Education Incorporated (INQAAHE).
  - 3. APQN is a non-profit, non-government organization.
- 3.1. APQN's mission is to enhance the quality of higher education in the Asia-Pacific Region through strengthening internal and external quality assurance in all kinds of organizations and extending the cooperation among them;
- 3.2. APQN's value is committed to the quality of higher education and is supportive of both internal and external quality assurance in the Asia-Pacific Region;
- 3.3. APQN's vision is to promote quality culture; to be a self-sustaining non-government and non-profit organization; and to be the first point of reference, efficient in its operations and share information among members;
- 3.4. APQN has four principles: 1) procedure-based; 2) capacity building; 3) self-reliance and information-sharing; and 4) sustainable development for final goal;
  - 3.5. The ultimate goal of APQN is "Dissolving Boundaries for a Quality Region".
  - II. Purpose
  - 4. The purpose of APQN is:
- 4.1. to promote good practices in developing an effective and comprehensive quality culture of higher education in the Asia-Pacific Region;



- 4.2. to foster research activities in quality assurance practices for rebuilding the employability oriented higher education in Asia Pacific Region;
- 4.3. to provide advice and expertise in order to assist in the development of new quality assurance organizations in the region;
- 4.4. to facilitate cooperation among Quality Assurance Agencies (QAAs) and Higher Education Institutions (HEIs), and recognize each other's decisions and judgment;
- 4.5. to assist APQN members in determining the quality standards operating across national borders;
- 4.6. to ensure better-informed international recognition of qualifications throughout the region;
  - 4.7. to assist in the development and application of credit transfer systems;
- 4.8. to enhance the mobility of students between institutions both within and across national borders;
- 4.9. to make the APQN members aware of and alert against the dubious accrediting practices and organizations;
- 4.10. to promote the interest of the Asia-Pacific Region by effective representation vis-à-vis interacting with other networks and international organizations.

#### III. Methods

- 5. APQN achieves its purpose through a range of methods, including:
- 5.1. dissemination of information through APQNews, documents, journals, anthologies and books, whether in paper-based or electronic form;
- 5.2. training and development through seminars, workshops, conferences and staff capacity building;
- 5.3. developing and using databases of experts and good practices both in EQAA and international networks such as INQAAHE,CHEA/CIQG and other appropriate organizations working on accreditation and quality assurance in education:
- 5.4. recognition and dissemination of good practices through Asia-Pacific Quality Register (APQR), Asia-Pacific Quality label (APQL) and APQN Quality



#### Awards (AQA) and so on;

5.5. other appropriate means as determined by the General Council or the Board.

#### IV. Finance

- 6. The APQN's financial year is from January 1 to December 31. The APQN Annual Financial Statement must be audited and published in the "APQN Annual Report".
- 7. Funding for APQN is derived from membership fees, grants, donations or other earnings and fees. APQN may seek donations and may derive income as determined by the General Council or Board for a period of 3 years.
  - 8. APQN may set fees and levy charges for its products and services.
- 9. APQN owns intellectual property rights for the paid products or fully-supported projects that are under the APQN budget.
  - 10. Membership fees are set as determined by the General Council.
- 11. The assets and income of APQN shall be applied solely in furtherance of its above-mentioned purpose, and no portion shall be distributed directly or indirectly to the members of the organization except as bona fide compensation for services rendered, or expenses incurred on behalf of the organization.

#### V. Membership

- 12. APQN has five categories of membership: Full Member, Intermediate Member, Associate Member, Institutional Member and Individual Member.
- 12.1. Full Members are either organizations responsible for assuring the academic quality of post-secondary institutions or education programs other than their own, or organizations responsible for assuring the quality of external quality assurance agencies, which meet the conditions for membership as expressed in the membership criteria of APQN, as decided by the General Council.
- 12.2. Intermediate Members are either organizations responsible for assuring the academic quality of post-secondary institutions or education programs other than their own, or organizations responsible for assuring the quality of external quality assurance agencies, but which do not fully meet the conditions for membership as expressed in the membership criteria of APQN, as decided by the



#### **General Council.**

- 12.3. Associate Members are organizations with a major interest and active involvement in evaluation, accreditation and quality assurance in higher education, but without the responsibility for assuring the quality of institutions, education programs, or external quality assurance agencies as described in Section V. Clause 12.1.
- 12.4. Institutional Members are institutions of higher education in the region that are in good standing with the relevant quality assurance agency if one exists.
- 12.5. Individual Members are representatives of academic or the QA community with a major interest and active involvement in the development of quality and research in higher education and the purpose of APQN.
- 13. APQN grants Observer status to those who are interested in Outside the Asia-Pacific Region, including external QAAs; institutions with a major interest in evaluation, accreditation and quality assurance in higher education; other regional networks that have major interests and strong links with the region.
- 14. Those within the APQN region who satisfy the membership criteria referred to in Section V. Clauses 12.1-12.5, are accepted as members of APQN on completion of the online 'Membership Application' and payment of the initial joining fees and annual membership fee determined by the General Council.
  - 15. The procedure for admission is as follows:
- 15.1. the Secretariat verifies that the request for membership complies with either of the conditions mentioned in Section V. Clauses 12.1-12.5 and makes a recommendation about the membership category; and
- 15.2. the Secretariat's recommendation is presented to the Board for approval.
- 16. Only Full and Intermediate Members are eligible to participate in the governance and administration of APQN.
- 17. Associate, Institutional and Individual Members may participate in the Annual General Meeting (AGM) and other meetings of the General Council, but without the right to vote.
  - 18. All members may:
  - 18.1. benefit from APQN's activities, collaborate in the attainment of



APQN's purposes; and exercise their rights according to this Constitution.

- 18.2. participate in APQN Academic Conferences (AAC) and AGMs, APQN online forums and other APQN meaningful events;
- 18.3 promote members' branding by using the APQN logo on their website or relative documents;
- 18.4 develop different kinds of collaborations among QAAs and HEIs through AACs;
- 18.5 co-organize international seminars, workshops or forums together with APQN in the local context;
  - 18.6 apply for the annual APQN Award;
- 18.7 have access to the Consultant Data Base and get advice on general and specific QA matters;
- 18.8 receive APQNews, the Annual Report, the APQN Brochure and other documents in e-form;
- 18.9 publish their qualified research papers in the APQN Anthology after AAC.
  - 19. All members undertake to:
  - 19.1. abide by this Constitution;
  - 19.2. comply with APQN decisions and resolutions; and
- 19.3. pay, in due time, the fees or any other contributions determined in accordance with this Constitution.
- 20. The procedures for disciplining of members are as described in Section V. Clauses 21 .21.4 and 32.6, and in Section IX.
  - 21. Membership is withdrawn if the member:
  - 21.1. withdraws its membership in writing to the Secretary;
- 21.2. fails to maintain the conditions that allowed their initial admission, as set out in this Constitution;
  - 21.3. does not fulfill the obligations set out in this Constitution; or
  - 21.4. acts in APQN's name without authorization.
  - 22. All members will be listed in the online register on the APQN website.



- 23. All members may, upon request, view any records and relevant documents of APQN if not available on the website provided that they peruse the documents in person and by appointment.
- 24. Notwithstanding anything in this Constitution, no member organization shall be expected, by virtue of its membership of the Network, to do anything that contradicts the rules and requirements of that organization.

#### **VI. Governing Bodies**

- 25. The governing bodies and authorities of APQN are the General Council and the Board.
- 26. The General Council is comprised of Full Members, Intermediate Members, Associate Members, Institutional Members and Individual Members of APQN, each represented by one nominated person.
- 27. The General Council shall meet at least once every year and notice of the meeting shall be given via email at least 21 days in advance.
- 28. All APQN notices to APQN members shall be given via e-mail and published on the APQN website.
- 29. The Full and Intermediate Members present at an in-person meeting of the General Council constitute a quorum for the meeting; for an electronic meeting, 30% of the Full and Intermediate Members of APQN constitute a quorum.
- 30. Full and Intermediate Members are entitled to vote by proxy at the AGM using an appointment of proxy form available on request.
- 31. Elections for the Board of Directors will be held by electronic ballot, or other means, according to the procedures agreed by the General Council.
  - 32. The responsibilities of the General Council are to:
- 32.1. elect the President, Vice-President and other four Directors of the Board;
  - 32.2. consider the reports from the Board;
  - 32.3. set the annual fees and any other contribution to be paid by members;
  - 32.4. consider and approve APQN annual financial statements;
  - 32.5. make decisions necessary for the satisfactory operation of APQN; and



- 32.6. exclude, on the recommendation of the Board, any member who disregards this Constitution.
- 33. Meetings of the General Council shall be conducted by the President (or in the absence of the President the Vice-President, or in the Vice-President's absence, by a Chair elected by the General Council for this purpose) and in accordance with accepted meeting procedures.
- 34. The decisions of the General Council shall be adopted by a simple majority of voting members.
- 35. Amendments to the APQN Constitution will require a three-quarters majority vote of the Full and Intermediate Members, and at least 21-day notice will be given of any resolution to alter the APQN Constitution.

#### VII. The Board

- 36. The Board of APQN consists of the President, immediate Past President, Vice-President and Secretary/Treasurer(ex-officio), and four other elected directors, and other directors whom the Board may decide to co-opt, to a maximum of four co-opted directors on the Board, provided immediate past president can have only one term ex-officio, if he/she has already served 3 successive elected terms on the Board.
- 37. Each elected Board director is nominated from Full and Intermediate Member organizations.
- 38. No two elected Board directors should be from the same member organization.
- 39. The Board is elected by the General Council for a three-year period. Re-election to the Board or any position on the Board is permitted for a maximum of three successive terms, provided that re-elections can be sought by any member after a gap of at least one term.
  - 40. The role of the Board is to:
  - 40.1. actively promote the functions provided for in this Constitution; and
  - 40.2. implement the decisions of the General Council.
- 41. In furtherance of this objective, the Board may establish committees, such as the Membership Committee, the Finance Committee, the Office Bearers, etc.



- 42. The Board will appoint Project Group Leaders who, if not already directors of the Board, may be co-opted as directors of the Board to a maximum of two co-opted Project Group Leaders as outlined in Section VII, Clause 36.
- 43. The Board shall appoint a Secretariat, which must be a Full of Intermediate Member and whose Chief Executive or nominee shall be the Secretary/Treasurer of APQN and a director of the Board ex-officio. No member of APQN is eligible to host the Secretariat for more than three successive terms, provided that re-hosting can be sought after the gap of at least one term.
- 44. The Board shall meet in person no less than once a year. Each meeting shall be conducted by the President (or in the President's absence the Vice-President, or in the Vice-President's absence, by a Chair elected by the Board for this purpose) and in accordance with the accepted meeting procedures. Fifty percent of the elected directors of the Board constitute a quorum.
  - 45. The responsibilities of the President are to:
  - 45.1. actively represent APQN in all relevant events;
  - 45.2. chair General Council meetings; and
  - 45.3. liaise on behalf of APQN with INQAAHE and other organizations.
  - 46. The responsibilities of the Vice-President are to:
  - 46.1. serve as the President's backup where designated;
  - 46.2. monitor the activities of the Project Groups; and
  - 46.3. chair the Finance Committee.
  - 47. The responsibilities of the Secretary/Treasurer are to:
  - 47.1. arrange for APQN's publications and website;
  - 47.2. prepare APQN Annual Reports;
- 47.3. keep and maintain APQN's records (including the register of members);
  - 47.4. arrange and record the meetings of the General Council and Board;
  - 47.5. collect fees and subscriptions;
- 47.6. maintain any necessary bank accounts and make payments as required;



- 47.7. prepare APQN's financial statements for presentation at the AGM, and
- 47.8. carry out decisions of the Board and the General Council.
- 48. All cheques, drafts and bills must be authorized by the President, the Secretary/Treasurer or atleast2directors of the Board.
- 49. The directors of the Board will have custody of all relevant APQN documents. In the event of a Board director surrendering their position, all the documents will be handed over to acting directors of the Board.
- 50. Occasional vacancies can occur where a Full or Intermediate Member agency with which a Board director is associated
  - 50.1. ceases to be a Full or Intermediate Member of the Network;
  - 50.2. becomes insolvent; or
- 50.3. the Board director resigns from office by submitting a written notice to the Board thirty days in advance.
- 51. When an occasional vacancy occurs on the Board, the Board shall make an appointment to fill the vacancy for the remainder of the vacating Board director's term of office.

#### VIII. Dissolution

- 52. APQN may be dissolved by a three-quarter majority of voting members at an AGM.
- 53. Any assets of APQN at its dissolution shall be handed over to INQAAHE unless decided otherwise by the General Council.

#### IX. Dispute Resolution

- 54. Any disputes over the interpretation of this Constitution shall be resolved by simple majority vote at a meeting of the General Council.
- 55. Any disputes arising between APQN and one of its members, or between the members, shall be submitted in written form and/or served on the member in question, and shall be presented to the Board for discussion within 14 days after the delivery of the written notice.
- 55.1. Failure of the parties to resolve the dispute will result in a mediation meeting with a mutually agreed independent mediator within a further period of



- 14 days, at the expense of the member organizations.
  - 55.2. All parties must attempt to resolve the disputes at mediation.
  - 55.3. Dispute resolution must allow for natural justice to be applied.

#### The Board






## **Organizational Structure**

Conventionally, the President, Vice-President, Secretary/Treasurer gave reports one by one on behalf of the 5th APQN board. As the opening words,



President Jianxin Zhang mentioned the Brochure of APQN 15th Anniversary and the 222 members of APQN General Council as milestones of APQN development. In the President Annual Report, President Jianxin Zhang fist looked back the important things through the year, such as 2018 APQN AAC and AGM in Nagpur, India, the Brochure of APQN 15-year Anniversary (2003-2018), the 3rd "Global Summit" co-held by APQN and BAN-PT in Bali, Indonesia, the MPI-APQN tenth International Conference held at Macao Polytechnic Institute (MPI) in Macao, China, the new host of APQN Secretariat — Higher Education Evaluation Center (HEEC), China as well as the publication of APQNews Issue 17 & 18, etc. President Zhang also introduced APQN's goals and tasks in 2019. In order to express appreciation to the 5th APQN Board, the 5th board directors present at AGM were invited onto the stage. The meeting place burst into warm applaud to thank the 5th board directors' tireless volunteer work. Later on,

The meeting discussed 10 items: 1) 2020 APQN Academic Conference (AAC); 2)finance principles; 3)discussion on the process of APQN membership; 4) discussion on APQN-RR Joint Project on APQN Quality Label with "Russian Register"; 5) discussion on collecting data of Quality Information Portal; 6) discussion on Vice President, co-opted Board Directors; 7) discussion on APQN-HEED MoU; 8) discussion on MOU INQAAHE strategic partners; 9) PC Members' assignment as well as proposed initiatives and job allocated; 10) reviewing 2019-2020 APQN Calendar.

The Board decided to accept the Finance Principles which have been passed by the fifth Board on March 20, 2019. APQN finance has a veto over APQN leadership of the Board if the annual finance appears "deficit". Some measures must be taken to collect membership fee Membership. It is expected that the new account will be open within 3 months (before July).

In order to realize APQN vision of "being a self-sustaining Network" and its sustainable development, at the second Meeting, the board decided to stop the MoU without any payment. The Board also suggested that HEED can use the logo and brand name for distribution of the journal without APQN financial payment, then the new MoU can be signed in order to realize our common and shared value of "being committed to the quality of higher education in the region". The Board meeting ended with the decision of making "APQN Strategic Plan (2019-2022)" for sustainable development of APQN.

Later Prof/Dr. Jianxin Zhang, APQN President, and Prof. Angela Yung Chi Hou, APQN Vice-President, spoke about the promotion of APQR together with Board members. Dr. Jagannath Patil Informed about possible following Quality Assurance Agencies (QAAs) would likely to inclusion on APQR review process: 1) Finance Accreditation Agency (FAA), Kuala Lumpur, Malaysia; 2) Independent Agency for Accreditation and Rating (IAAR), Kazakhstan; 3) Mongolian National Council for Education Accreditation (MNCEA), Mongolia; and 4) Eurasian Centre for Accreditation and Quality Assurance in Higher Education and Health Care (ECAQA), Kazakhstan.

During the meeting, following issues are discussed and agreed as follows: 1) an amount of about 4000 USD earmarked towards expenses of APQR Secretariat; 2)APQR may be registered as legal entity at a suitable location / country.

### APQN Strategic Plan (2019-2022)

In order to realize the final goal of "Dissolving Boundaries for a Quality Region", the Sixth Board of APQN made the APQN Strategic Plan (2019-2022) .It got approved on May 30, 2019.

The sixth Board began its term on March 30, 2019 in the Annual General Meeting (AGM) in Colombo, Sri Lanka. To realize the mission of "being a self-sustaining Network, the first point of reference for advice or support, efficient in its operations and open in its information sharing", this Strategic Plan is made as the guidance for the new general council in the next three years (2019-2022)<sup>1</sup>.

The sixth Board will take on the persistent mission with new attitude and new perspectives. The five principles of the sixth Board are: 1) target-orientated principle; 2) project-orientated principle; 3) SMART Project principle (specific, meaningful, agreed-upon, results-oriented and tractable); 4) Win-Win Principle; and 5) principle of sustainable development. The five key words are "procedure-base, capacity-building, self-reliance, information-sharing and sustainable development". APQN Strategic Plan (2019-2022) will complete the following seven goals and actions along with ten targets in the next three years.

### **Global Yoga Accreditation Summit Held in New York**

On April 26-27<sup>th</sup> 2019, Global Yoga Accreditation Summit was held at United Nations Headquarters, New York. It is jointly organized by NAAC, PMI-UN & APQN. H. E. K. Nagaraj Naidu, Indian Ambassador to UN, Dr. H. R. Nagendra, Hon'ble Chancellor of S-VYASA, Bengaluru, Dr. Geetha Krishnan Gopalakrishna Pillai, World Health Organization, Geneva, Prof. Jianxing Zhang, President of APQN, China & Dr. Jagannath Patil, Adviser of NAAC & Convener were present.



April 26<sup>th</sup> 2019: In a historical move by the National Assessment and Accreditation Council (NAAC), the Global Yoga Accreditation Summit: Beginning of a Conversation towards a Global Ecosystem in Yoga Higher Education through Accreditation (GYAS) was organized at the UN Hall, UN Headquarters, New York, USA.

In close collaboration with the Asia Pacific Quality Network (APQN) and the Permanent Mission of India to the United Nations, GYAS was represented by over 40 key stakeholders best comprising international and national inter and intra governmental policy makers, key leaders of accreditation bodies and networks, quality assurance agencies, representatives of prominent yoga higher education providers, yoga experts, fraternity from the medical and psychology fields etc.

The inaugural was marked with the presence of dignitaries on the dais - H.E.K. Nagaraj Naidu, Ambassador, Deputy Permanent Representative at India's Permanent Mission to UN; Padmashri H. R. Nagendra, Hon'ble Chancellor of S-VYASA; Dr. Geetha Krishnan Gopalakrishna Pillai, World Health Organization, Geneva; Prof. Jianxing Zhang, President of APQN, China and Dr. Jagannath Patil, Adviser of NAAC & Convener - GYAS.

GYAS was firmed on a recent desk-top study in progress (2019), undertaken by NAAC, an Autonomous Institution of University Grants Commission of India



revealed that nearly 60 University departments and a large number of other Higher Education Institutions such as colleges and stand alone yoga institutions etc., within the country are offering various levels of yoga programmes – which add up to almost 200 in number. Further, the study revealed that though there are thousands of Yoga sets ups both in the West and other parts of the world offering a multitude of trainings however, main stream programmes offered under the higher education ambit is almost negligent – not exceeding ten in numbers.

In order to create the pertinent space for authentic yoga into the mainstream education and make it as a career choice, NAAC has taken the historic initiative on coming out with the First Draft of The Yoga Accreditation Manual, finalized on the 6th March 2019 at Bengaluru for all Yoga programs within a HEI in the country. This also implied that Yoga programs offered are well contained within a homogeneous international standard quality framework.

Pinning the origins of Yoga to the Indus Valley and furthering the scope of accreditation outside the Indian territory, the GYAS was set on the vision to enable co-ordination and co-operation amongst various bodies dealing with recognition /accreditation bodies in Yoga worldwide through mutual dialogue and processes towards creating a global ecosystem in mainstreaming Yoga Programs and its accreditation within the higher education ambit amalgamating a harmonization between the traditional philosophy and modern practices.

The delegates appreciated the visionary effort by NAAC under patronage of Shri. R. Subrahmanyam, IAS, MHRD Secretary, Prof. D.P. Singh, UGC Chairman, Dr. Virander S. Chauhan, Chairman, Executive Committee (EC) of NAAC and Prof. S.C. Sharma, Director, NAAC

Shri Prem Bhandari, Chairman Jaipur Foot, USA and officials at permanent mission of India to UN extended valuable support to organize event at UN headquarters at New York, USA.

### The APQL Review at SIU, India

The expert review panel of the Asia-Pacific Quality Network (APQN) comprising of Prof/Dr. Jianxin Zhang (leader), Ms. Stamenka Uvalic-Trumbic, Dr. Mark Frederik and Dr. Jagannath Patil, visited Symbiosis International (Deemed University), (SIU), India from April 4-9, 2019. This is the first ever review of the



internationalization processes of an Indian University, conducted by APQN.

"Symbiosis International Cultural Centre" was established by Prof. S. B. Mujumdar, in the year 1971 for the welfare of the foreign students who came to the city of Pune to pursue their education. The guiding principle behind the establishment of Symbiosis was "Vasudhaiva Kutumbakkam" meaning "the world is one family". The objective of the institution was to bring international students closer to the Indian students, help them overcome the numerous problems they were facing as foreigners, and ensure that not only would they receive good education but also become goodwill ambassadors after returning to their own countries. The Ministry of Human Resource Development, Government of India, conferred "Deemed to be University" on Symbiosis International University in 2002. The vision of SIU is "promoting international understanding through quality education".

The three-day review assessed the internationalization processes and impact on different stakeholders. This included an assessment of a conducive environment which encompasses state of the art infrastructure through site visits to Hostels, Recreation & Wellness Centre(RWC), Symbiosis Centre of Health Care (SCHC), Grounds, Mess (Dining), Aqua Point, Symbiosis Studios, Symbiosis Centre for Behavioral Studies (SCBS), Multi-Faith Room, Cafeteria, Library, Symbiosis School of Culinary Arts and Biological Labs. The review panel also got the opportunity to visit Symbiosis's Afro- Asian Museum and Dr. Babasaheb Ambedkar Museum and Memorial.

The days then progressed with presentations on SIU's vision, mission,



governance, international linkages, extensive scholarships offered to foreign students and Indian students for global immersion experiences, policies, procedures, foreign language programmes, support for students & faculty, research capital, quality assurance systems, and infrastructural wealth. This was validated through meetings with influential stakeholders in the Indian Higher Education policy circle at the conference, mentors and representatives from collaborating partner institutions. Focus group discussions took place with international students, Indian students studying abroad, current and past international student council members, skype interactions with graduates, observation of global classroom engagement and a detailed perusal of relevant documents.

SIU is one of the few exceptional universities that has embarked on this international journey for the heartfelt cause of



enabling and empowering international students in India. The panel was very impressed with the genesis and the progress SIU has made in this direction by not only strengthening its processes and governance but leaving a footprint on society through its visible impact. APQN President Prof/Dr. Jianxin Zhang declared that the panel will recommend APQL Council to grant the APQN Quality Label to SIU. This label is International Accreditation of Internationalization initiative to support, develop, improve and enhance international excellence in HEIs and programs in Asia Pacific region. SIU is the first university in India to be conferred this prestigious label and this is fitting as they are the pioneers in the field of internationalization for higher education.

### **APQR Review to MNCEA in Mongolia**

APQR is register of external quality assurance agencies that demonstrate certain thresholds of maturity launched by APQN as stakeholder initiative in Asia–Pacific region. The independent external review by peers is the backbone of the Register. While the primary purpose of the Register is to acknowledge well developed quality assurance agencies. So far 5 Quality Assurance Agencies (QAAs) in Asia Pacific region have successfully completed review process to be included on APQR. Another 4 QAAs are at various stages of review process.

Mongolian National Council for Education Accreditation (MNCEA) expressed its interest to the Asia-Pacific Quality Register Council (APQRC) to be considered for inclusion on the Asia-Pacific Quality Register (APQR).

Accordingly, MNCEA submitted a Self-Evaluation Report (SER) and supporting documents to APQRC. The SAR provides overview of functions of MNCEA, taking account of all its QA activities carried out during the period 2015 to 2018 and touching on some other functions of MNCEA, as per relevant rules and laws of Mongolia.

Based on SER & other supporting documents of MNCEA, APQRC had conducted the on-site visit for Mongolian National Council for Education Accreditation (MNCEA) on June 02 - 04, 2019 at the office of MNCEA in Ulaanbaatar, Mongolia. The review conducted against criteria of APQR based on the APQN's membership criteria and the Chiba Principles.

APQRC constituted a review panel to MNCEA comprising following: Prof. Angela Hou Yung-chi (Chair): Executive Director, Higher Education Evaluation & Accreditation Council of Taiwan (HEEACT), Chinese Taipei. Dr. Jagannath Patil (Member & Facilitator):, Adviser, National Assessment and Accreditation Council (NAAC), India, Immediate Past President of Asia Pacific Quality Network [APQN], India. Dr. Diana Hallerud (Member): Associate Director of Accreditation, Accreditation Council for Business Schools and Programs (ACBSP), United States.

Commendations and recommendations to MNCEA on each criterion are precise,



evidence based and self – explanatory statements by APQR review panel.

Finally the Panel's assessment on MNCEA is "substantially compliant" based on each criterion of APQR.

### **APQR Review to ECAQA in Kazakhstan**

The Eurasian Centre for Accreditation and Quality Assurance in Higher Education and Health Care (ECAQA) as a quality assurance agency that recognized by the Ministry of Education and Science of the Republic of Kazakhstan has expressed its interest to the Asia-Pacific Quality Register Council (APQRC) to be considered for inclusion on the Asia-Pacific Quality Register (APQR).

ECAQA is a specialized/professional accreditation agency in medicine, biomedicine and health sciences that included in Directory of Organizations that Recognize/Accredit Medical Schools (DORA) of the Foundation for Advancement of International Medical Education and Research (FAIMER), USA and the Council for Higher Education Accreditation International Quality Group (CHEA/CIQG) International Directory, USA.

The APQR Review Panel to ECAQA included the international experts: Prof/Dr. Jianxin Zhang (Chair and Facilitator) from China, Vd. Jayant Deopujari (Co-chair) from India and Prof. Rie Mori from Japan.

The panel visited ECAQA on November 1-2, 2019 and the external evaluation was based on the interviews with ECAQA's staff members, ECAQA's Board members, the external assessors (reviewers), representatives from Kazakhstan Ministry of Health, Members of the ECAQA's Accreditation Council and Chair Dr. Alma Syzdykova, Director of Department for Science and Education, University Medical Centre Corporate Fund Nazarbayev University and Prof. Salomuddin Yusufi, the WHO Executive Board Member (elected), Vice-Rector for Science and Research of Avicenna Tajik State Medical University, Medical students' association and with a range of other relevant stakeholders, review of agency's quality assurance programme and documents as well as the validation of statements in the "ECAQA's Self-Evaluation Report" with relevant details in the attachments.

During the onsite visit, the APQR Review Panel has found convincing evidence for the ECAQA's external and internal quality assurance and its operation, including the presentations of developments in Quality Improvement in Basic and Postgraduate Medical Education, CPD and Nursing Education in the Republic of Kazakhstan and interviews with the Director General of ECAQA Prof. Saule Sarsenbayeva, Adviser Dr. Farida Nurmanbetova, Chair of the ECAQA's Experts Board Associate Prof. Almagul Kuzgibekova, Chair of Expert Committees Dr.



Sholpan Kaliyeva, Dr. Gulmira Ibrayeva, Dr. Zaure Baygozhina.



The APQR Review Panel has met with a representative of the Association "Kazakhstan Medical Council" and visited the Museum of History of Kazakhstan Medicine and Healthcare at the Asfendiyarov Kazakh National Medical University. Also the Panel has visited the Kazakh Medical University of Continuing Education and the Kazakh-Russian Medical University that accredited by the ECAQA.





ECAQA ensures and improves academic quality, training of healthcare professionals, contributes to introduction of the quality culture within higher education institutions as well as promoting the establishment and development of transparent national quality assurance system on health professions education.

ECAQA actively collaborate with broad range of partner organizations through international organizations and with quality assurance agencies across national borders. The ECAQA confirmed and demonstrated that its operation was based on the fundamental principles of the WHO and WFME Guidelines for accreditation of medical education as well as the Standards and Guidelines for Quality Assurance in the European Higher Education Area (ESG 2015). With the development tendency of internationalization, ECAQA stands out as a leading QAA in health care to unite all profession in medicine and health sciences.

Based on the onsite-visit at the ECAQA and its external evaluation, the APQR Review Panel finds that ECAQA is in either "fully" or "substantial" compliance with the APQR Criteria. The Panel recommends and agrees that ECAQA has been accepted onto APQR.

### **APQR Review to IAAR in Kazakhstan**

The Independent Agency for Accreditation and Rating (IAAR) in the Republic of Kazakhstan expressed its interest to the Asia-Pacific Quality Register Council (APQRC) to be considered for inclusion on the Asia-Pacific Quality Register (APQR).

In the beginning of 2017 IAAR had registered at the EQAR (the European Quality Assurance Register for Higher Education). Based on "The Inclusion of Other Quality Assurance Organizations' Review onto the Asia-Pacific Quality Register" approved in 2016 by the APQR Council, acceptance onto the Register is based on an external quality assurance agency (EQAA) being found to be "substantially compliance" against 11 APQR criteria, incorporating the Chiba Principles. The APRQ Council decided to adopt desk review (instead of site visit) to IAAR.

On Nov. 20-Dec.20, 2019, a review panel of three experts, Prof. Dr. Jianxin Zhang (Chair and Facilitator) from China, Dr. Maiki Udam (panellist) from Estonia, Oksana MATVEEVA from Russia conducted desk review to the Independent Agency for Accreditation and Rating (IAAR) in the Republic of Kazakhstan.

The SER of IAAR and "Final Report of ENQA Review" are viewed. The SER is a thorough and critical examination of IAAR, taking account of all its QA functions and activities carried out during its 8-year development (2011 - 2019) and touching on some other functions of IAAR. The hyperlinks and appendices to the SER included the following documents referred to by the review panel: 1) National reports and documents, such as Law of RK "On Education"; 2)IAAR regulations and internal documents, such as IAAR organizational structure, IAAR Strategic Plan for 2016-2020; 3)Final Report of ENQA Agency Reviews to IAAR in 2016, and ESG 2015.

The Independent Agency for Accreditation and Rating (IAAR) is a non-profit accreditation agency established in 2011 with the aim of improving the national system for quality assurance in education - one of the leading international accreditation agencies in the accreditation of higher, technical, and additional education.

Based on its review of documents in the "IAAR's Self-Evaluation Report", the review panel finds IAAR is either "fully" or "substantial" compliance with the APQR criteria. The Panel therefore recommends to the APQR Council that IAAR be accepted onto the Register on Dec.20.




# Reports by the Board

Overall APQN has completed the tasks in 2019, except the fourth Global Summit. However, consideration needs to be given to the long-term sustainability of the outcomes and impacts of APQN activities. This will require a proactive stance and continuity of the APQN heritage.

### II. APQN's Goal and Tasks in 2020

In 2019, the sixth Board and the fourth Secretariat took the office, and we have successfully completed most of the activities. The new board made "APQN Strategic Plan (2019-2022)", 2019 is the year of the transitional stage between the old and new Board. The sixth Board has spent 6 months to amend APQN Constitution (version 9.0), and tried the best to realize APQN's mission, value and goal. In 2020, Based on "APQN Constitution(version 9.0)" and "APQN Strategic Plan (2019-2022)", APQN will focus on the following "1-2-3-4-5 Plan", i.e.1 Mission, 2 Values, 3 Visions, 4 Principles and 5 Tasks:

### 1. One Mission

To enhance the quality of higher education in the Asia-Pacific Region through



strengthening internal and external quality assurance in all kinds of organizations and extending the cooperation among them.

- 2. Two Values
- 1) To be committed to the quality of higher education;
- 2) To be supportive of both internal and external quality assurance in the Asia-Pacific Region.
  - 3. Three Visions
  - 1) To promote quality culture;
  - 2) To be a self-sustaining non-government and non-profit organization;
- 3) To be the first point of reference, efficient in its operations and share information among members.
  - 4. Four Principles
  - 1) Procedure-based;
  - 2) Capacity building;
  - 3) Self-reliance and information-sharing;
  - 4) Sustainable development for final goal.
  - 5. Five Tasks
- 1) To establish ongoing financial viability and stability, such as exploring additional funding sources externally which can include donation, commissioned work, and sponsorship of events or publications by governments, agencies/organizations, philanthropists and other relative stakeholders;
- 2) To populate and maintain the website database and make information accessible to all, such as canvassing its members to identify relevant requirements for quality assurance, e.g. APQN Quality Register(APQR) and APQN Quality Label(APQL);
- 3) To well organize APQN Academic Conferences (AAC) just as 2019 in Sri Lanka, at the same time to facilitate APQN Global Summit such as what NAAC, HEEACT and BAN-PT did in 2016, 2017 and 2018, to co-host Quality Assurance Forum just like that in Macao Polytechnic Institute (MPI), to launch research projects just as Self-funding project of "APQN Sustainable Development, to co-train external assessors just like that of NAEAC in Pakistan;
- 4) To strengthen relations with other international, regional and national networks/organizations within and outside the Region, such as promoting the communication with more international, regional and national quality assurance and networks/organizations, such as INQAAHE, ENQA ANQAHE, AQAN, CHEA and others: and
  - 5) To broaden the base of services to its members to ensure visibility and



sustainability of network activities, such as strengthening ongoing initiatives of APQR, APQN Anthology of APQN Academic Conferences and so on.

By completing the activities mentioned above, APQN can achieve the following 10 purposes specified in "APQN Constitution": 1) to promote good practices in developing an effective and comprehensive quality culture of higher education in the Asia-Pacific Region; 2) to foster research activities in quality assurance practices for rebuilding the employability oriented higher education in Asia Pacific Region; 3) to provide advice and expertise in order to assist in the development of new quality assurance organizations in the region; 4) to facilitate cooperation among Quality Assurance Agencies (QAAs) and Higher Education Institutions (HEIs), and recognize each other's decisions and judgment; 5) to assist APQN members in determining the quality standards operating across national borders; 6) to ensure better-informed international recognition of qualifications throughout the region; 7) to assist in the development and application of credit transfer systems; 8)to enhance the mobility of students between institutions both within and across national borders; 9) to make the APQN members aware of and alert against the dubious accrediting practices and organizations; and 10) to promote the interest of the Asia-Pacific Region by effective representation vis-à-vis interacting with other networks and international organizations.

The past 16 years has been a long road of challenges on which APQN achieves the vision of "to be a self-sustaining non-government and non-profit organization". The future year is a new path of "Dissolving Boundaries for a Quality Region", a non-profit QA organization that restlessly enhancing HE quality in the Asia-Pacific Region.

### **III. Offering Thanks**

As the two terms (2016-2019; 2029-2022) consecutive APQN president of my service, I have many persons to thank.

First of all, I must thank 240 members of APQN General Council who trusted me as the 6<sup>th</sup> President, all the members of APQN Board (Vice President: Galina Motova; APQN Secretary/Treasurer: Pingping Liu; Immediate Past President: Jagannath Patil; Board Directors: Deepthi C. Bandara, I-Jung Grace Lu, Farida Nurmanbetova; Administrator: Le Fang and Yingjie Xu), who have entrusted me with administrative responsibility and supported me greatly.

Second, I must express appreciation to APQN former Presidents as well as the pioneers! Together with all the Board Directors, with the lead of the 1<sup>st</sup> President, Mr. Peter Cheung, the 2<sup>nd</sup> President, Ms. Concepcion Pijano, the 3<sup>rd</sup> President, Dr. Antony Stella, the 4<sup>th</sup> President, Dr. Jagannath Patil, APQN has made extraordinary development. I firmly believe, through the joint-efforts of 240 members in APQN big harmonious family, with APQN spiritual legacy - Dedication, Sharing, Serving, Innovation and Sustainable Development - APQN is bound to achieve the ultimate goal of "dissolving boundaries for a quality region". With the pioneering spirits and unremitting efforts of all APQN persons, APQN will certainly "move from one success to another success".

### Vice President Annual Report by Galina Motova

2019 presented a challenge for the stability of APQN's work due to the re-election of the Secretariat. Thanks to the titanic effort by President Prof. Dr. Jianxin Zhang, Immediate Past President Dr. Jagannath Patil and the new Secretariat (Ms. Liu Pingping), we managed to overcome the crisis and stabilize our work.

As APQN Vice President and the Chair of the Review Committee I took the responsibility over some functions of the Secretariat:

First, it was necessary to obtain more accurate contact information about all APQN members. The contact information placed on the website was outdated as this information is entered when an organization is granted APQN membership and it is not reviewed unless there is a special request from the member. This situation hinders the communication between the Secretariat and the APQN members. I sent out requests and received feedback about the changes in the contact information. All the changes have been introduced on the APQN site and in the mailing list.

Second, APQN applicants have been having certain difficulties when filling in the on-line application form, which slowed down the review process. For the sustainable development of the organization it is very important to have an influx of new members. At the same time, it is very important for new members to receive clear and user-friendly services, both during the application process and in receiving the feedback. I have collected all available information from the APQN site and the sites of the applicants. The review process by the Review Committee has been initiated and the feedback and the mailing of membership certificates have been set up.

Third, when the work of the Secretariat got stabilized I continued the review process of new members. Unfortunately, this work does not proceed as fast as we would like.

An important stage in the work of the APQN Board was the Amendment of APQN Constitution. The text of the Constitution has been reviewed and new amendments have been introduced in the 9<sup>th</sup> version of the document. I took an active part in discussing and reviewing the articles of the Constitution. And also I provided feedback to the "Three-year Strategic Plan for APQN Sustainable



Development (2019-2022)" and other documents regulating APQN activity.

The traditional stage in the preparation of the annual APQN conference is gathering and reviewing materials, which will be presented by the participants at the plenary and parallel sessions. This is an important stage, as it determines whether the presentations of the participants are going to be interesting and useful for the listeners and whether the conference itself is relevant for its permanent participants. Following on the results of the Conference the Anthology of materials is complied. For the last four years I have taken part in the reviewing of the submitted articles. I consider this work very important both for the organization of the Conference and for me personally as it facilitates professional growth and better understanding of the quality assurance processes taking place in the Asia-Pacific Region.

Apart from this, in the preparation time for the Conference there is a lot of work to be done in order to review and assess incoming documents, such as nominations for APQN quality awards, bids for organizing following events, etc. I took an active part in discussing and reviewing such documents.

On my suggestion an initiative project involving a series of webinars was launched whose aim is to foster cooperation and internationalization of HEIs and quality assurance agencies. In 2019 three webinars were organized (July 2, October 10, and December 10). About 100 organizations (accreditation agencies and HEIs) took part in the webinars. The most active participants were organizations from Russia and Central Asia. The webinars were held under the auspices of APQN. The first webinar was opened by APQN President Jianxin Zhang. The webinars will continue their work in 2020 and will serve as a communication platform for the exchange of opinions and experience, finding new partners for cooperation. This communication mode could be also suggested for the on-line forums of APQN members.

## **Secretary/Treasurer Report by Pingping Liu**

Thanks to the trust and support of Prof. Jianxin ZHANG and all the other Board Directors, it's been a great honor that Shanghai Education Evaluation Institute (SEEI) is approved to host the APQN Secretariat for another new term. To effectively conduct the Secretariat, a team of 4 experienced staff from SEEI has been assigned, with Ms. Pingping LIU as the Secretary/Treasurer, both Ms Yingjie XU and Mr. Le FANG as the Administrator and Ms Cunyao FAN as the accountant. The team has devoted plenty of time and energy to the operation of the Secretariat: (a) taking

the initiative to complete the routine work of the Secretariat, such as collection of membership fees, daily maintenance of the website, and all-around support for the events, meetings and etc.; (b) conscientiously carrying out the tasks assigned by the Board, such as consultation for the members' opinion on the revision of the Constitution, the assistance for the review of new members' entry applications and the support for the work of APQR; and (c) communicating effectively and solving the daily queries from the members and interested parties, such as queries about the application of membership, queries about the academic conference and queries about APQN quality awards and so on The main work is listed as follows.

1. APQN Members and the Board. Under the guidance of President Jianxin ZHANG and all Board Directors, currently the number of APQN members of all types has successfully reached 240 from 42 countries/territories. We received 9 new entry applications which are being reviewed. Thanks for the Board's tremendous support to the new team members of the outgoing Secretariat, an effective communication channel between us has been well formed.

### 2. Events and Projects

The 2019 APQN Annual Conference (AAC) and Annual General Meeting (AGM) were held from March 22-25, 2019 in Sri Lanka, and 131 participants from 21 countries and regions attended the conference, representing QAAs, HEIs and educational authorities of different countries.

On September 16th, 2019, an email named "To Seek your Opinions on the Amendments of APQN" was sent to all members, after which the Secretariat has sorted and summarized their opinions.

In addition, the Secretariat also has supported the Board Directors to release the Call for Members and Experts to Join APQN Projects, to invite interested members to join in the existing/proposed projects of common interest and to conduct short-term projects related to APQN objectives.



- 3. Routine Work. The Secretariat has concentrated fully on the management and supervision of the APQN routine work, including:
- (a) "Call for Nominations for 2020 APQN Awards, Call for Expression of Interest to Host 2021 AAC and AGM, APQN-EDUVALE Call for 2020 Applications for Sponsorship, and publishing the 2018 Conference Proceedings, etc. The Secretariat has been engaged in planning the activities, preliminarily reviewing the applications, making recommendations to the Board, conducting coordination and supervision, providing technical support in the process and etc.
- (b) When it comes to APQN members, the Secretariat has updated information for the existing members, and provided detailed and thoughtful consultations. Furthermore, the Secretariat is devoted to calling for new members, such as approaching potential members in the APQN database and non-member participants of APQN activities, answering queries in the process of application and giving timely feedback after pre-review of the application, providing support for the review of Membership Review Committee and undertaking follow-up work for the review of the Board.
- (c) The Secretariat has also cooperated with the website server, Kramah Software in India to continue the website maintenance this year. APQN received 9 new members via the application system on the website, which has facilitated the development and growth of APQN.

### 4. The Financial Statement

On March 2020, the Secretariat organized the annual audit for the 2019 Finance Statement and the audit report has been provided by a Certificated Public Accountant, authorized by Shanghai Education Commission under the supervision of the government. In brief, the total income in 2019 counts for 40969.99 USD while the total expense is 29277.21 USD; Balance for 2019 is 11692.78 USD. The annual membership fees have been received from 65 members by Dec.31, 2019. The Secretariat is still working on receiving unpaid 2019 membership fees at present. The details can be seen in the APQN Finance Statement.

In closing, I would like to express my sincere gratitude to the APQN Board Directors, especially President Prof. Jianxin ZHANG and Vice President Prof. Galina MOTOVA. I would also say thanks to Mr. Aijun ZHOU, the former Secretary/Treasurer and Dr. Shuo WANG, the former Administrator for the support in the period of handover. Last but not least, I would highly appreciate the support of all APQN members, especially Dr. Hui FENG, President of Shanghai Education Evaluation Institute, the host of the Secretariat for the generous kind-contribution, and also those interested parties for APQN. I believe all of us would like to work together to bring a brighter APQN for the world.
